**Position Summary:**

Under direct supervision of the Fire Lieutenant, the Firefighter/EMT–Paramedic protects the life, property, and natural resources of the Pueblo of Laguna. Responds to a variety of emergencies, such as structure and wild-land fires, medical and trauma emergencies, hazardous materials incidents, or rescue and extrication emergencies. Consistently applies Core Values supporting Workforce Excellence. Employee must maintain confidentiality of all privileged information.

*This list of duties and responsibilities is illustrative only of the tasks performed by this position and is not all-inclusive.*

**Essential Duties & Responsibilities:**

- Works within a Paramilitary Rank structure environment and adheres to and follows the chain of command.
- Responds to fire alarms, emergency medical services (EMS), and all other emergencies when dispatched.
- Locates, rescues, and removes victims from dangerous or potentially dangerous situations.
- Creates openings in buildings for entry, cross-ventilation and/or roof ventilation.
- Controls property loss created by fire by removing occupants and belongings, diminishing water damage, and conducting proper salvage and overhaul techniques.
- Provides emergency care to injured persons and those overcome by fire, smoke or other life-threatening emergency, evaluates signs and symptoms of patients, and provides prompt and medical treatment including advanced life support, invasive care, artificial respiration, extrication, and preparation for transport.
- Administers medication orally or by injection adhering to regulations and protocols with medical guidance from physician.
- Transports patients to appropriate medical facility and reports to medical facility personnel on condition and care of patients.
- Transports bodies of deceased persons to mortuaries and homes.
- Handles large diameter fire hose used for fire suppression and containment of fire.
- Communicates with superior officer or Medical Control Emergency Physician (MCEP) during fire and EMS responses respectively.
- Inspects buildings for fire hazards and compliance with fire prevention ordinances.
- Maintains apparatus, living quarters, fire station, equipment, and grounds, to remain in good and clean condition.
- Participates in EMS fire drills, equipment demonstrations, and training courses, such as hydraulics, pump operations, and firefighting tactics and strategies.
- Maintains positive relations with community members and agencies by educating and informing on fire prevention and related issues.
- Drives firefighting apparatus such as an ambulance, tanker, pumper, brush truck, and operates equipment effectively.
- Completes medical records, drug logs and inspects medication assuring adherence to established protocol. Provides reports to the Lieutenant and/or Captain at the beginning and end of working shift.
- Prepares and completes required reports on all activities, responses, incidents. Assures required follow up.
- Maintains technical knowledge by attending training classes and seminars on firefighting/EMS methods, techniques, safety, and related fire prevention activity.
- Communicates with local, state, regional and outside agencies and assists as needed.
- Coordinates emergency scenes with other public safety, local groups/organizations, or agencies utilizing the National Incident Management System (NIMS) and Incident Command System (ICS) as required by Homeland Security.
- Contributes to team effort toward accomplishing tasks and achieving results.
- Performs other duties as assigned.

### **Minimum Qualifications:**

High School Diploma or GED required. NEMEMT-Paramedic License required. Firefighter I Certification required. Must participate in the LFPP physical fitness agility test. ACLS-Advanced Cardiac Life Support Certification and PALS-Advanced Life Support preferred. Firefighter II Certification must be obtained within three (3) years of hire. Fluency in the Laguna language preferred.

### **Background Investigation Requirements:**

The Pueblo of Laguna has a Suitability Policy for background investigation processes. Every position in the government operation is reviewed and designated at one of three risk levels. The determination is commensurate with public trust responsibilities and attributes of the position which includes job duties. The Firefighter/EMT-Paramedic is designated at a High Risk Public Trust (HRT) position.

### **Knowledge, Abilities, and Skills:**

- Knowledge of applicable federal, state, county, and local laws, regulations, and requirements.
- Knowledge of equipment used in firefighting.
- Knowledge of fire behavior and fire suppression principles, methods, techniques, and practices.
- Knowledge of hazardous materials handling and safety and wild land fire techniques and operations.
- Knowledge & understanding of the National Incident Management System (NIMS), and Incident Command System (ICS).
- Knowledge of and skill in the use of IV pumps.
- Knowledge of basic computer skills, and data entry.
- Ability to work within a Paramilitary Rank Structure and follow a chain of command,
- Ability to safely and effectively utilize a variety of ladders.
- Ability to understand the difference between utilization of water or high-expansion foam and skill to effectively apply.
- Ability to communicate effectively, both verbally and in writing. Fluency in the Laguna language preferred.
- Ability to interact and maintain good working relationships with individuals of varying social and cultural backgrounds.
- Ability to give and receive orders, and to follow instructions in verbal and written format.
- Ability to work as a team member in a structured working environment.
- Ability to maintain confidentiality.
- Ability to demonstrate moral character when dealing with people.
- Ability to prepare accurate reports and present detailed, accurate, and objective oral presentations.
- Ability and skill to safely operate tools, apparatus, vehicles, and equipment used in fire suppression, rescue, and medical assistance operations.
- Ability to work extended hours and various work schedules.
- Ability and skill to integrate training, experience, and common sense to identify potentially dangerous situations, make effective and logical decisions, and exercise the appropriate measure of tact or force to resolve the situation with minimum injury to self or other persons as well as minimum damage to property.
- Ability to accept the dangers and stresses, regimentation, discipline, and time demands of firefighting.
- Ability to maintain physical condition to perform essential duties.
