**Position Summary:**

Under the direct supervision of the Natural Resources Manager, provides support and leadership to the forestry crew. Oversees the safe performance of a variety of assignments that maintain and protect healthy forests. Consistently applies the Pueblo's Core Values in support of Workforce Excellence. Maintains confidentiality of all privileged information.

*This list of duties and responsibilities is illustrative only of the tasks performed by this position and is not all-inclusive.*

**Essential Duties & Responsibilities:**

- Plans and conducts hazardous fuels removal projects including slashing, and pre-commercial thinning.
- Use GPS equipment to locate treatments sites and make boundary locations for treatment sites.
- Fells trees; trims; bucks-up fuel wood; hauls logs and slash to designated area.
- Stacks and prepares slash piles for controlled burns.
- Directs and trains crewmembers in the proper and safe use of chainsaws and other equipment; ensures crew's engagement and productivity.
- Directs and trains crew members in the proper and safe methods of carrying out duties.
- Ensures the observation of safety rules for a safe working environment.
- Directs crew in the regular maintenance and minor repair of equipment.
- Records field data including acres cut, work location, work done, GPS locations, and mapping.
- Coordinates and schedules the use of heavy equipment.
- Drives field truck and hauls trailer on narrow roads to transport crew members, tools, and equipment to worksite.
- Periodically reports on progress of projects; coordinates the submission of required reports.
- Researches vendors of personal protection supplies and equipment; requests quotes and completes appropriate purchase documents.
- Assists, as directed, the Pueblo's Emergency Management Program in its response to public emergency incidents.
- Obtains required certifications within specified time limits; maintains/enhances technical knowledge by attending relevant training and workshops.
- Performs other duties as required.

**Minimum Qualifications:**

One (1) year of forestry work experience, including supervisory responsibilities, required. One (1) year of experience in GPS equipment and Microsoft Office Program use required. BIA/Forest Service S-212 Class Certification preferred; obtains within six (6) months of hire. FEMA/ICS 100 and 200 Certifications preferred; obtains within six (6) months of hire. A combination of relevant education and related work experience may be considered. Fluency in the Laguna language preferred.

**Background Investigation Requirements:**

The Pueblo of Laguna has a Suitability Policy for background investigation processes. Every position in the government operation is reviewed and designated at one of three risk levels. The determination is commensurate with public trust responsibilities and attributes of the position which includes job duties. The Crew Leader is designated as a Low-Risk Public Trust (LRPT) position.

- Knowledge of tree planting and seedling care.
- Knowledge of data collection and processing of collected data.
- Knowledge of GPS processes and procedures.
- Knowledge of and skill in the safe operation of chainsaws and other potentially dangerous tools and equipment.
- Knowledge, skill, and ability to safely drive field vehicle with trailer over rough terrain.
- Knowledge of report writing.
- Knowledge of basic FEMA policies, regulations, and processes regarding emergency incident response and management.
- Ability to maintain a safe working environment.
- Ability to work independently and meet strict time lines.
- Ability to foster good working relationships with/among crew members
- Skill and ability in use of GPS equipment.
- Skill and ability to interpret/compare quotes for equipment and supplies.
